



# (U) WORLDWIDE: Worldwide Threat to Shipping (WTS) Report, 16 December 2020–13 January 2021

#### 1. (U) Scope Note

(U) The Worldwide Threat to Shipping (WTS) message provides information on threats to merchant vessels, the shipping industry, and other maritime stakeholders worldwide in the last 30 days. This report is produced primarily to inform merchant mariners and naval forces.

#### 2. (U) Warnings and Advisories:

A. (U) 2021-002-Gulf of Guinea-Piracy/Armed Robbery/Kidnapping for Ransom. Effective Date: 9 January 2021. Expiration Date: 7 July 2021. Piracy, armed robbery, and kidnaping for ransom (KFR) continue to pose a significant threat to U.S. flagged operators with vessels transiting or operating in the Gulf of Guinea (GoG). According to the Office of Naval Intelligence's "Shipping Threat Reports" website at https://www.oni.navy.mil/News/Shipping-Threat-Reports/, as of last 31 December 2020, 98 reported incidents of piracy and armed robbery at sea occurred in the GoG region. This is a 24-percent decrease in the total number of incidents from the same period in 2019, with the number of kidnappings and hijackings declining by 16 percent. Almost a third of all incidents involve a hijacking or kidnapping. Approximately 51 percent of all incidents of piracy and armed robbery took place off the coast of Nigeria, a decrease from the 71 percent in 2019 and is an indication that pirates are traveling farther in order to target vessels. Criminals and armed KFR groups have used motherships to support operations of up to 200 nautical miles from shore. Additionally, the recently issued "Best Management Practices to Deter Piracy and Enhance Maritime Security Off the Coast of West Africa including the Gulf of Guinea" (available under the Geography - Gulf of Guinea pull-down menu at www.maritimeglobalsecurity.org/) provides additional guidance and resources for operating in this area.

B. (U) 2021-001-Persian Gulf, Strait of Hormuz, Gulf of Oman, Arabian Sea, Red Sea, Gulf of Aden, and Indian Ocean-Threats to Commercial Vessels by Iran and its Proxies. Effective Date: 7 January 2021. Expiration Date: 6 July 2021. Multiple maritime threats have been reported in the geographic areas described above, including a mine placed on the hull of a Liberia-flagged tanker off the coast of Iraq in the Persian Gulf on 31 December 2020 and the Iranian seizure of a South Korea-flagged tanker in the Strait of Hormuz on 4 January 2021. Heightened military activity and increased political tensions in this region continue to pose serious threats to commercial vessels. If a U.S.-flagged commercial vessel suspects that it is being hailed from a source falsely claiming to be a U.S. or coalition naval vessel, or is being asked for positions or information on coalition military vessels or aircraft operating in the area, the U.S. Fifth Fleet Battle Watch should be immediately informed. Vessels operating in this area are advised to establish contact with both the United Kingdom Maritime Trade Organization (UKMTO) and the NAVCENT Naval Cooperation and Guidance for Shipping (NCAGS) Watch, and to include both on all update or incident report emails, as detailed above, so awareness will be enhanced without creating an additional reporting burden. ## 3. (U) Summary:

- A. (U) NIGERIA: On 13 January, the Singapore-flagged container ship MAERSK CARDIFF was reportedly approached approximately 150 NM south-southwest of Bonny.
- B. (U) SAINT MARTIN: On 10 January, one robber boarded a catamaran anchored in Marigot Bay.
- C. (U) COLOMBIA: On 9 January, robbers boarded a vessel underway 33 NM west-southwest of Cartagena.
- D. (U) NIGERIA: On 8 January, it was reported that four sailors, kidnapped from the Marshall Islands-flagged product tanker AGISILAOS on 29 November 2020, had been released.
- E. (U) NIGERIA: On 8 January, a bulk carrier underway approximately 40 NM south of Brass was approached by one skiff with eight persons onboard.
- F. (U) EGYPT: On 6 January, authorities seized a shipment of drugs after discovering a container in Port Said with over eight million Captagon pills and almost nine tons of hashish.
- G. (U) SAINT MARTIN: On 5 January, robbers boarded a catamaran anchored in Marigot Bay.
- H. (U) NIGERIA: On 5 January, local media sources reported that two underway passenger boats were boarded by robbers in the Bonny waterways, Rivers State.
- I. (U) HAITI: On 4 January, six robbers boarded a bulk carrier anchored in Port au Prince.
- J. (U) SAINT MARTIN: On 22 December 2020, a yacht in the Grand Marche anchorage had its dinghy (in the water and unlocked) stolen while the owners were onboard.

#### 4. (U) Details: Monthly Incidents by Region

(U) This section lists reports of active violence against shipping, credible threats to shipping, or the potential for a situation to develop into a direct threat to shipping over the last 30 days. Every effort is made to ensure that incidents are not double-counted. In the event that double-counting is detected, or an incident is later found to

be different than initially reported, an explanation of the cancellation of the inaccurate report will be made in at least one message prior to dropping the erroneous report.

## A. (U) NORTH AMERICA:

1. (U) MEXICO: On 31 December 2020, in a refuge for the endangered vaquita porpoise in the upper Gulf of California, one boat was destroyed during an attack on vessels operated by a conservation NGO group. The crew aboard one of the vessels was retrieving a gillnet from the water when fishermen aboard at least five pangas began throwing lead weights and Molotov cocktails at both crew and military officials who were onboard. According to the NGO group, as the vessel began to leave the scene, one of the pangas swerved in front of it and smashed into the hull. The smaller vessel broke in two and its two passengers were thrown into the sea. A second NGO vessel recovered the two men, who were then given emergency first aid. Doctors with the Mexican Navy arrived and treated the two, one of whom wasn't breathing when he was brought aboard. While the men were being treated, the NGO group reported, two other fishermen boarded the NGO vessel, threatened the crew and officials onboard, and smashed a camera that was filming the incident. ## **B.** (U) CENTRAL AMERICA - CARIBBEAN - SOUTH AMERICA:




Figure 1. Central America – Caribbean – South America Piracy and Maritime Crime

1. (U) SAINT MARTIN: At 0340 on 10 January, the owner of a catamaran anchored in Marigot Bay was onboard and heard noise on deck. He found a woman hiding near the mast; she then jumped overboard and swam ashore. A locker had been opened and rifled through, with several items removed but left behind. A police report was made. (www.safetyandsecuritynet.org)

- 2. (U) COLOMBIA: On 9 January, robbers boarded a vessel underway 33 NM west-southwest of Cartagena near position 10:16N 076:12W. (IMB; Clearwater Dynamics)
- 3. (U) SAINT MARTIN: On 5 January, robbers boarded an anchored catamaran in Marigot Bay while the crew was asleep. They stole personal electronics, a laptop, binoculars, a search light, sunglasses, a wallet with cash and credit cards, as well as a backpack with other personal items. A report was made to local police. They indicated that this was the fourth such incident recently. (www.safetyandsecuritynet.org)
- 4. (U) HAITI: On 4 January, the duty officer onboard a bulk carrier anchored in Port au Prince noticed a suspicious echo on the radar and asked the security patrol to investigate. The security patrol noticed a boat with six robbers, armed with a gun, boarding the bulker using a ladder with hooks. The alarm was raised and the crew retreated into the accommodation area. The robbers threatened the chief engineer who was attempting to secure an open accommodation door. The incident was reported to the coast guard and local authorities. The coast guard responded and boarded the vessel to carry out a search and to investigate. Ship's properties were reported stolen. The crew and vessel are safe. (IMB)
- 5. (U) SAINT MARTIN: On 22 December 2020, a yacht in the Grand Marche anchorage had its dinghy (in the water and not locked) stolen while the owners were onboard. They discovered the cut line at 2200. (www.safetyandsecuritynet.org)
- C. (U) ATLANTIC OCEAN AREA: No current incidents to report.
- D. (U) NORTHERN EUROPE BALTIC: No current incidents to report.
- E. (U) MEDITERRANEAN BLACK SEA:




Figure 2. Mediterranean – Black Sea Piracy and Maritime Crime

1. (U) EGYPT: On 6 January, authorities seized a shipment of drugs after discovering a container, with over eight million Captagon pills and almost nine tons of hashish inside, transiting through Port Said. The shipment was said to be headed for Libya. According to reports, the container originated from Lebanon and was loaded on 19 December in a warehouse belonging to a Lebanese exporting firm before being sent to the Port of Beirut. #### F. (U) WEST AFRICA:




Figure 3. West Africa Piracy and Maritime Crime

- 1. (U) NIGERIA: On 13 January, the Singapore-flagged container ship MAERSK CARDIFF was reportedly approached approximately 150 NM south-southwest of Bonny. MDAT-GoG has confirmed that the vessel and crew are safe. A security vessel that was dispatched by Nigerian authorities to assist the vessel had arrived at the scene and confirmed that no suspicious craft were in the area. (www.fleetmon.com; Clearwater Dynamics)
- 2. (U) NIGERIA: On 8 January, it was reported that four sailors kidnapped from the Marshall Islands-flagged product tanker AGISILAOS on 29 November had been released after 40 days in captivity. (www.urdupoint.com; www.offshore-energy.biz; Clearwater Dynamics)
- 3. (U) NIGERIA: On 8 January, a bulk carrier underway approximately 40 NM south of Brass was approached by one skiff with eight persons onboard. The skiff approached to within 0.3 NM of the vessel, resulting in the master carrying out evasive maneuvers and increasing speed, and the crew mustering in the citadel. As a result of the master's actions and the vessel's 11-meter freeboard, the skiff aborted the approach. The crew is reported as safe. (Clearwater Dynamics)
- 4. (U) NIGERIA: On 5 January, local media sources reported that two underway passenger boats were boarded by robbers in the Bonny waterways, Rivers State, near position 04:30N 007:16E. The robbers forced the passengers to jump overboard before escaping with the two boats, resulting in two of the passengers drowning while the remaining victims struggled to swim to the nearby mangroves. Local security agencies were mobilized after receiving distress calls from some of the passengers. When they arrived at the scene of the incident, they were able to recover the bodies of the two drowned passengers and several of the survivors; however, a number of people are still reported missing. (www.guardian.ng; Clearwater Dynamics)
- 5. (U) CONGO: On 4 January, robbers armed with knives boarded a container ship anchored at Pointe Noire North Anchorage, position 04:42S 011:44E. The alarm was sounded and all crew mustered in the citadel. The robbers stole ship's stores and escaped. The incident was reported to port control. All crew is reported safe. (IMB)


- 6. (U) NIGERIA: On 29 December 2020, the crew on a tanker reported a suspicious approach by a speedboat approximately 94 NM southwest of Brass near position 02:44N 006:24E. The skiff, which had five armed men on board, approached within 50 meters of the tanker's starboard side. When the master carried out evasive maneuvers, the skiff departed the area. (IMB; Clearwater Dynamics)
- 7. (U) GHANA: On 26 December 2020, a robber boarded a cargo vessel in Takoradi Anchorage, near position 04:53N 001:41W. When the duty officer noticed the robber on the forecastle and raised the alarm, the robber fled with ship's property. (Clearwater Dynamics)
- 8. (U) ANGOLA: On 24 December 2020, robbers boarded a research vessel in Luanda Anchorage, near position 08:44S 013:17E. The robbers stole several mooring lines from the forecastle without being spotted. (Clearwater Dynamics)
- 9. (U) NIGERIA: On 24 December 2020, pirates released five Ghanaians who were kidnapped from the Ghanaflagged general cargo vessel AM DELTA. They were in good health and unharmed. (Clearwater Dynamics; www.splash247.com)
- 10. (U) NIGERIA: On 22 December 2020, the crew of the Singapore-flagged tanker BW PAVILION LEEARA reported a suspicious approach by a speedboat approximately 121 NM southwest of Brass, near position 02:26N 005:24E. When the speedboat approached the tanker on the port side, the captain increased speed, altered course, and notified his company. The speedboat subsequently changed course and increased speed to continue its pursuit of the tanker. During the incident, the crew mustered in the citadel, apart from the captain and two other crew members who remained on the bridge. The speed boat aborted the chase after 45 minutes. (Clearwater Dynamics)
- 11. (U) NIGERIA: On 21 December 2020, Lebanon's Foreign Ministry announced that three of its citizens, along with two Egyptians, had been released after they were kidnapped from the cargo ship MILAN off Nigeria on 26 November. (www.elnashra.com; www.middleeastmonitor.com)
- 12. (U) NIGERIA: On 21 December 2020, pirates boarded the Malta-flagged container ship PORT GDYNIA approximately 100 NM south-southwest of Brass, near position 02:37N 005:37E. The crew safely evacuated to the citadel and they heard gunfire inside the ship at that time. The pirates eventually departed the ship and the crew was able to continue on its voyage to Bata, Equatorial Guinea. (Clearwater Dynamics)
- 13. (U) NIGERIA: On 19 December 2020, pirates boarded the Singapore-flagged container ship MAERSK CADIZ approximately 85 NM south of Brass, near position 02:39N 006:14E. Three security vessels responded to the incident, but the pirates had departed the container ship. The crew is safe. (Clearwater Dynamics; Dryad Global; www.fleetmon.com)
- 14. (U) NIGERIA: On 18 December 2020, pirates reportedly boarded the Bermuda-flagged LNG tanker LNG LAGOS II 170 NM southwest of Brass, near position 02:17N 003:54E. (Dryad Global; www.fleetmon.com)
- 15. (U) NIGERIA: On 16 December 2020, pirates boarded the Cameroon-flagged cargo vessel STEVIA while underway from Port Harcourt to Abidjan, Ivory Coast. The boarding took place near position 03:50N 006:09E, approximately 28 NM southwest of Brass. Eight crew members were kidnapped. (Dryad Global)

## G. (U) ARABIAN GULF:

1. (U) IRAN: On 3 January, Iran's Revolutionary Guard Corps (IRGC) seized a South Korea-flagged tanker in the Persian Gulf. Seoul confirmed the seizure of a South Korean chemical tanker by Iranian authorities in the waters off Oman and demanded its immediate release. Several Iranian media outlets, including Iranian state TV, said that the

IRGCN captured the vessel for polluting the Gulf with chemicals. The semiofficial Tasnim news agency published pictures showing what it identified as IRGCN speedboats escorting the tanker HANKUK CHEMI, which it said was carrying 7,200 tons of ethanol. They reported that the vessel's crew members, including nationals of South Korea, Indonesia, Vietnam, and Myanmar, had been detained. The tanker is being held at Iran's Bandar Abbas Port. The tanker has 20 crew members, according to South Korea's foreign ministry. (www.gcaptain.com)

- 2. (U) IRAQ: On 31 December 2020, Iraqi ordnance disposal personnel defused a large mine discovered on the hull of an oil tanker in the Persian Gulf and evacuated its crew. A statement came a day after two private security firms said that sailors feared they had found the limpet mine on the Liberia-flagged tanker POLA in the waters off the Iraqi Port of Basra. - H. (U) INDIAN OCEAN EAST AFRICA RED SEA: No current incidents to report.
- I. (U) EAST ASIA SOUTHEAST ASIA:
- 1. (U) INDONESIA: On 3 January, three robbers armed with knives boarded an anchored bulk carrier at Muara Berau Anchorage, near position 00:15S 117:34E. The robbers were discovered by the duty crew at the forecastle store room. They stole ship's stores and escaped. The incident was reported to local authorities. (IMB; Clearwater Dynamics)
- J. (U) INDIAN SUBCONTINENT: No current incidents to report.
- K. (U) AUSTRALIA NEW ZEALAND PACIFIC OCEAN AREA: No current incidents to report.

#### 6. (U) Appendix B: Definitions and Sourcing

- **A.** (U) **Definitions:** In order to promote consistent use of accurate terms of reference, we use the following definitions to describe a range of criminal antishipping activity and impediments to safe navigation in our worldwide reporting and analysis.
  - (U) **Attempted Boarding** Close approach or hull-to-hull contact with report that boarding paraphernalia were employed or visible in the approaching boat.
  - (U) **Blocking** Hampering safe navigation, docking, or undocking of a vessel as a means of protest.
  - (U) **Boarding** Unauthorized embarkation of a vessel by persons not part of its complement without successfully taking control of the vessel.
  - (U) Fired Upon Weapons discharged at or toward a vessel.
  - (U) Hijacking Unauthorized seizure and retention of a vessel by persons not part of its complement.
  - (U) Kidnapping Unauthorized forcible removal of persons belonging to the vessel from it.
  - (U) **Hijacking/Kidnapping Combination** Unauthorized seizure and retention of a vessel by persons not part of its complement who forcefully remove crew members from vessel when disembarking.
  - (U) **Robbery** Theft from a vessel or from persons aboard the vessel.
  - (U) Suspicious Approach All other unexplained activity in close proximity of an unknown vessel.
- **B.** (U) **Sourcing:** ONI derives information in this report primarily from government agencies, piracy reporting centers, maritime security companies, and open press.
