## (U) WEST AFRICA – GULF OF GUINEA

1. (U) **GHANA**: On 27 January at 2140 local time, a robbery occurred onboard a bulk carrier whilst anchored at Takoradi anchorage. Two robbers boarded the vessel before being detected, which caused the vessel to sound her foghorn making the perpetrators flee the vessel. The crew is reported safe and nothing was stolen. (Clearwater Dynamics/CLOSED)
2. (U) **\*\*LATE REPORT\*\* ANGOLA**: On 20 January at 2155 UTC, a robbery occurred onboard an Antigua Barbuda-flagged bulk carrier. One perpetrator boarded with a knife at Luanda anchorage. The duty crew spotted the perpetrator on the forecastle causing the vessel to sound her foghorn making the perpetrator flee. The crew was reported safe and nothing was stolen. (Clearwater Dynamics/CLOSED)
3. (U) **GABON**: On 11 January at 0235 UTC, a kidnapping occurred onboard a Chinese fishing vessel while underway between Port Gentil and Libreville. Nine crew members were abducted comprising of five Chinese and four Indonesian nationals. The vessel and its three remaining crew members were escorted into Libreville by the Gabonese Military vessel Mendene. (Clearwater Dynamics/CLOSED)

## (U) EAST ASIA – SOUTHEAST ASIA

1. **(U) PHILIPPINES:** On 26 of January at 2100 local time, a robbery occurred onboard a container ship whilst in Manila Bay. Multiple perpetrators broke into the bosun store by breaking the doors security arrangement, and also attempted to gain access to the engine room. The crew is safe and two hydrant cups and one walkie talkie was reported stolen. (Clearwater Dynamics/IFC)
2. **(U) PHILIPPINES:** On 25 of January a robbery occurred onboard a container ship whilst anchored in Manila Bay. The duty crew observed two perpetrators on the forecastle. The alarm was sounded and then the crew mustered. The perpetrators escaped using a small craft. The crew is safe and five 20L paint drums and three coils of electrical cord was stolen. (Clearwater Dynamics/IFC)
3. **(U) PHILIPPINES:** On 15 of January a robbery occurred on a Panama-flagged bulk carrier while anchored in Bauan Anchorage, Batangas Bay. The duty crew discovered the robbery during routine rounds. The crew is safe and the ship's property was reported stolen. (Clearwater Dynamics/IFC)



## (U) Appendix B: Definitions

(U) In order to promote consistent use of accurate terms of reference, we use the following definitions to describe a range of criminal antishipping activity and impediments to safe navigation in our worldwide reporting and analysis.

- > (U) **Attempted Boarding** – Close approach or hull-to-hull contact with report that boarding paraphernalia were employed or visible in the approaching boat.
- > (U) **Blocking** – Hampering safe navigation, docking, or undocking of a vessel as a means of protest.
- > (U) **Boarding** – Unauthorized embarkation of a vessel by persons not part of its complement without successfully taking control of the vessel.
- > (U) **Fired Upon** – Weapons discharged at or toward a vessel.
- > (U) **Hijacking** – Unauthorized seizure and retention of a vessel by persons not part of its complement.
- > (U) **Kidnapping** – Unauthorized forcible removal of persons belonging to the vessel from it.
- > (U) **Hijacking/Kidnapping Combination** – Unauthorized seizure and retention of a vessel by persons not part of its complement who forcefully remove crew members from vessel when disembarking.
- > (U) **Robbery** – Theft from a vessel or from persons aboard the vessel.
- > (U) **Suspicious Approach** – All other unexplained activity in close proximity of an unknown vessel.
